

### **Guide on issue of power of attorney**

This is a power of attorney form that you can use if you want to authorise another person with full legal capacity to exchange your information and possibly act on your behalf in connection with the Danish Debt Collection Agency's (Gældsstyrelsen) collection of your debt.

You must fill in your contact details as well as the power of attorney holder's contact details.

You must decide whether the power of attorney is to be unlimited or limited. In case of a limited power of attorney, you must specify the debt covered by the power of attorney and whether it only applies to exchange of information or also allows the power of attorney holder to act on your behalf.

### **Validity of the power of attorney**

The power of attorney is valid for three years from the date of signature.

As the principal, you may withdraw the power of attorney at any given time by notifying the Debt Collection Agency thereof either orally or in writing.

In case of a new power of attorney, you must submit a new duly completed and signed power of attorney to the Debt Collection Agency.
